- Indicates potential omissions in the performance of mining operations and provides direct guidance to supervisory staff for corrections.
- Coordinates with the geological, geotechnical, and planning representatives during the shift.
- Maintains best practice procedures for contractor activities.
- Implements and promotes various initiatives following the principles of inspection, planning, decision, execution, and monitoring.
- Capture, validate and record mine operations data.
